

On September 11, 2012 at the AFD Firefighters Union Hall, Local 244, a Memorial service was held to commemorate the 911 disasters which occurred On September 11, 2001 at the New York World Trade Center, the Pentagon, and The airplane crash in Shanksville, Pennslyvania. Remembered were the victims On that fateful day which included Frefighters, Policemen, Public Safety people, EMT's civilians as well as military personnel. Bill Raupfer and Tom Romero of The retiree's Honor Guard spoke of the heroic deeds of those firefighters and Public Safety Personnel who rose to the occasion and were successful in saving Many lives that day. Local Firefighter's Union President Diego Arencon welcomed Everyone and joined in the memorial service. The theme, "We Shall Never Forget," Was remembered. Mike Murphy, John Serino, Bill Raupfer, and Tom Romero, the AFD Retiree's Honor Guard, paid tribute to the fallen by "Striking The Four Fives," An old Fire Service custom of honoring our departed comrades. By striking the "Four Fives," we remember the deaths of our brothers and sisters who perished in the terrorist Attacks of 911. Attending the memorial were Retiree President Sam Trujillo, retired Firefighters, active duty firefighters, citizens and community leaders.



September Meeting - On September 12, 2012 President Sam Trujillo called the 145 th meeting of the AFD Retired Firefighter's Association to order at 7:10 P.M. The meeting was held at the firefighter's Union Hall, Local 244, 4100 Edith N.E. 

Fred was born in Hot Springs, NM (before it was Truth or Consequences, NM) he grew up in Hatch, NM. His father was in the Fire Department in Hatch. Fred fell in love with the concept of serving people; he decided to make firefighting a Career. He went north to Albuquerque, where he became an Albuquerque Firefighter in 1960. Fred moved back home to Deming, NM where he retired Chief of the Deming Fire Department.

Fred became Fire Chief of the Deming Fire Department in 1967 and retired in January of 2000. One of his accomplishments was dropping the ISO Rating from a Seven to a Five. During his tenure, he added the Rescue and EMS system. Fred's accomplishments are too numerous to list. When I heard, he worked for AFD, that is when I decided to mention our **AFD Retirees Association** to him.



Ernest "Ernie" Armijo Dies

Our brother retiree firefighter Ernest "Ernie" Armijo passed away on August 23, 2012 At age 84. "Ernie" had fought a long battle with kidney failure. He joined AFD in July, 1953 and retired after 31 years service with the department in June, 1984. He served under five fire chiefs, Art Westerfeld, Simon Seligman, Ray Kuhn, Arthur Martinez, and Leonard Ortega.

When he joined the department the old fire station # 1 was located at Second Street and Tijeras N.W. in the City Hall Complex. Rookie Training was rather short, mostly on the job training. Firemen were designated firemen 4 th class. Then a fireman's pay was about



\$200.00 per month. Ernie rose quickly to the rank of driver and worked at most stations driving pumpers and ladder trucks. When he worked at the old Station # 3 at Bryn Mawr and Central NE. The famous route 66 passed by the fire station prior to I-40 being built. During his assignment there he met people from all around the world who were traveling route 66.

Ernie had a quick smile and was a pleasant and upbeat person. He was always ready to mentor young firefighters, teaching them pump operations, streets, and how to handle the aerial ladder. He was good at teaching young drivers to tiller the aerial truck and to maneuver the apparatus into tight places. he took pride that his apparatus was always in first class condition and ready for the next fire. Our most sincere condolences to the entire Armijo family.

Death of Sam S. Chavez

Retired Lieutenant and brother firefighter Sam S. Chavez passed Away on Monday, August 27, 2012 at age 80. Sam was from Ft. Sumner New Mexico and was a veteran of the United States Army. He joined the Albuquerque Fire Department during October, 1959. Training was only eight weeks long and Assistant Chief Ray Kuhn was the training Chief. Sam was hired by the late Fire Chief Art Westerfeld and there was only eleven fire stations in Albuquerque at that time. There was only 250 firemen on the department then. Firemen worked 60 hours a week. To retire a fireman was required To have 30 years on the job and must have reached 55 years of age.



Shortly after the old fire station # 13 near Winrock Shopping Center was opened in the spring of 1964 Sam was assigned there. In July 1964 he was promoted to driver. He spent the latter part of his career working at fire stations on the East side of town. That included stations # 13 and # 5. During his assignment at station # 13 he worked on the first Diesel driven pumpers, purchased by the department, 1000 GPM Macks. He was promoted to Lieutenant in February, 1968.

Sam was a dedicated firefighter who loved his job and always made sure that the men and apparatus under his charge was fit and ready for the next fire or emergency. After serving his community and the department for 23 years he retired in April, 1982. On behalf of the AFD Retired Firefighter's Association we extend our most sincere condolences to the entire Chavez family.

FELLOW FIREFIGHTERS AND FRIENDS HOLD SUCCESSFUL FUND RAISER FOR FIREFIGHTER GIL POHL WHO HAS CANCER



HISTORICAL REFLECTIONS

In 1908 Fred Russell joined AFD during the horse drawn apparatus era. He quickly rose through the ranks to Assistant Chief. He saw the transition from horses to motorized fire apparatus in 1912. Albuquerque accepted delivery of a gasoline driven 1912 American La France pumping engine that year. From about 1918 to the early 1920's Russell was in and out of the office of Fire Chief due to the efforts of the firefighters attempts to unionize. Generally he sided with the firefighters. By the early 1920's (exact date unknown) he was appointed to Chief permanently. He served as Chief until his death in August, 1931. Art Westerfeld was appointed to Chief in 1931. Westerfeld had joined the department in 1918 as a driver/mechanic. He was hired because very few people of the day could drive a vehicle. Westerfeld holds the distinction of serving as Albuquerque's Fire Chief Longer than any other person (1931 - 1962), 31 years. He died of cancer in February 1962 while still serving as Fire Chief. Simon Seligman was appointed to Fire Chief following the death of Chief Westerfeld.


HISTORY, FIRE STATION # 2, 301 HIGH STREET S.E. (HIGHLAND STATION)

- 1908 Albuquerque's second Fire Station # 2 was built and placed into service.

 This station was located on Edith Street between Silver and Lead Avenues S.E.
- 1927 Fire Station # 2 was relocated to 301 High Street S.E. and a new station constructed of stone was built. (See Photo attached).
- 1956 Fire Station #2 was rebuilt at 301 High Street S.E. During the renovation, (mid-1950's), Engine # 2 crew was temporarily relocated to the vacant fire station on the Sante Fe Railroad property.

The Railroad Fire station is located at the intersection of 1st Street & 2nd Street S.E. Renovation cost, \$35,000. The original block walls still stand behind the walls of the current building facade.
