



LETTER OF THANKS


Retired AFD Lieutenant Bernie Martinez

ORLANDO O.G. DURAN DIES - It is with sincere regrets that we announce The death of our brother firefighter Orlando "O.G." Duran, age 82, who Passed away on August 23, 2019. He was hired on June 1, 1960 by the Late Fire Chief Art Westerfeld. The fire department was growing because The new fire station # 12 had just opened. More firefighters were being Hired to staff the new fire station # 1 that had recently opened. When Orlando was hired the department had difficulty hiring firemen and had just gone on a recruiting drive in the States of Louisiana, Texas, Arkansas, Arizona, Oklahoma, Colorado and California. The pay was only \$320 per month and the work week was 60 hours. Orlando liked his job and was a responsible happy go lucky fellow who had many friends. He was well respected by his fellow firefighters and supervisors alike. He was a licensed plumber and had his own plumbing company. He was also a musician and had his own band and played at various functions throughout Albuquerque. His last assignment was driver on Engine # 6. After serving 24 years with the department and with the City of Albuquerque Orlando retired on June 30, 1984.

Joe P. Kindrick Dies – Our good friend and fellow retired firefighter District Chief Joe Paul Kindrick age 87, passed away on Sunday September 1, 2019. He joined AFD on April 22, 1959. After serving over 26 years of faithful and dedicated service with the Fire Department and to the Albuquerque community he retired on December 31, 1986. He was hired along with three other firefighters by Fire Chief Art Westerfeld. The fire Academy (Fire Training Division) was formed in 1957 and he was one of the first groups of firemen to complete the 8 weeks fire training program headed by Assistant Chief Ray Kuhn. The beginning pay for new firemen was \$228 per month. The work week was 72 hours. When a fireman worked overtime or an extra shift The pay was at regular time. There was no overtime pay. The first five years of his Career was spent working at the old fire station #3 at Bryn Mawr and Central N.E. A pumper, ladder truck and the District Chief ran out of that station. His fellow Firemen were: Assist Chiefs S.B. Skidmore & Carl Macaluso. The officers were Captains "Slim Davidson," Arthur Martinez, Lts. Maurice Cordova, and Manuel Jiminez. Firefighters were: Ernest Rael, Pilo Bessera, Nestor Tapia, Amado Pargus, Bob Rowland, Herman Bishop, Billy Chenault and Owen Metcalf. We called him

"J.P." He moved up the promotion ladder quickly. He was promoted to Driver in 1965, to Lieutenant in 1968, to Captain in 1974 and to District Chief in 1985. He was a congenial, personable man who was liked by everyone. When he was promoted to Captain he was assigned as an instructor at the Fire Academy for five years. After promotion to District Chief he was re-assigned back to the firefighting division where he was in charge of the East side fire district. After retirement he was an active member of the AFD Retired Firefighters's Association for 19 years. Our most sincere condolences are extended to the Kindrick Family.

"Ouadruplets" By, Luis Padilla (Big Bird)

In the late 1970's I was stationed at old Fire Station #3 (Monte Vista & Central NE). The crew on the pumper at that time consisted of Captain Gene Padilla, Driver Carmen Padilla Jr., Pipeman Joe Padilla, and myself (Luis Padilla).

It so happened that a Firefighter from Portland, Oregon was visiting the station right at shift change. When the shift bells hit and the vocal came on Captain Padilla gave the roll call for Engine #3 crew. It was Padilla, Padilla, Padilla, and Padilla. The Oregon Firefighter stared in amazement and finally asked if we were related. I answered him, "yes we are, we're quadruplets."

"The Fire Was Brought To Us" By, Herman R. Bishop

When I was the driver for District Chief Carl Macaluso at old Fire Station # 13 during 1965, we had a large number of fires in garbage trucks. The main cause of the fires was people putting hot ashes in cardboard containers and leaving them on the curb for the refuse department to pick up. To combat this problem the Fire Department staff conducted a training program for refuse workers and firefighters jointly. Numerous press releases were made to the general public about prevention of these type fires. Once it was discovered that a garbage truck was on fire the refuse workers were instructed to drive to the nearest vacant lot or open space, dump their load of garbage and call the Fire Department.

A few weeks after the training about how to handle garbage truck fires we received a call to Fire Station #8 (Menaul & Graceland). It was reported that there was a fire on the ramp of the fire station. When we arrived we found that another garbage truck had caught fire and that the driver had driven to the nearest fire station and dumped his load of garbage onto the ramp at station #8. This blocked Engine #8 from leaving the station but the firefighters started the Fire Engine, pulled the booster line and extinguished the fire.

The Chief's Driver

On our way home from the May monthly meeting last night "Slim" Davidson, District Chief retired, and I were reminiscing about the "GOOD" old days at AFD and it brought back a memory I would like to share with you if I haven't yet.

Back in 1959, when I was an acting driver, and the Chief Drivers never drove to the fires, (Only the Chiefs drove to the fires), I was driving for then Captain Louie Jurado, who was acting Assistant Chief. While we were returning from his house, where he was having lunch, we were dispatched to a fire in the Old Town Area. I immediately drove to the curb, and Captain Jurado and I switched places and proceeded to the fire. I was checking the map for the best route when I told the Captain to turn right at the next street. Well, Lo and Behold, he turned right in the next driveway! When we stopped in front of the two car garage, he turned to me and said, "Mister, where in the Hell are you taking me?" I responded, "Captain, I said the next street, not the next driveway!" (Louie Jurado was later promoted to District Chief. He frequently called his coworkers "Mister.")

MASCOT, AFD Station #1, A MONKEY NAMED "SPIDER" (By Herman R. Bishop)

Early in our careers (1950's & 1960's) we worked with old timers who joined the department during the 1920's and 1930's. Many of them told us of a pet monkey that the firemen had at the old fire station #1 at 2 nd and Tijeras NW. We were not sure if the stories were true or just fire house yarns.

Retired Deputy Chief Bruno Bernasconi recently brought us some old Albuquerque newspaper articles dating from the 1930's (exact dates unknown) that confirms indeed the firemen had a pet monkey during the 1930's. His name was "Spider." Where he came from or what happened to him is not known. The following newspaper article is about "Spider." (Reprint, exact date unknown)

"Spider Wins Bout with Fire Chief Art Westerfeld: Punches His Nose "Spider," the fire department monkey held high cards Sunday Afternoon in an argument With Fire Chief Art Westerfeld. The Chief stopped "Spider" from picking buds of the Flowers, and "Spider" got mad. A few minutes later the Chief tried to pet him, But "Spider" was still mad. He threw a right to the Chief's head that drew a welt from His forehead almost to the tip of his nose. The injury was still noticeable Monday, the next day.

When I worked at the old station #3 at Bryn Mawr and Central N. E. a fellow fireman, Trinidad Lopez, told me that the firemen at the old Station #1 had trained their pet monkey To jump down the hole for the fire pole from the second story and the firemen would Catch him in a heavy wool blanket. At the time I was not sure if the story was believable. Now that we found the news article verifying that there was a pet monkey maybe it Was true that he was trained to jump into a blanket.



LOYD MARES, AN ENCOUNTER WITH THE RUFFIANS - (By Herman R. Bishop)

After my appointment to District Chief Loyd Mares was my driver. Late one night we responded with Engine #2 to a house fire totally involved somewhere on South Edith Street. Engine #2 had laid 3 blocks of 2 ½ inch hose. As we approached the intersection Loyd parked the Chief's car in the intersection to prevent anyone from running over the hose. Later after the fire was extinguished I walked back to the Chief's car. As I approached the intersection a car load of four ruffians was parked shouting obscenities at Loyd and threatening to run over the fire hose. They demanded that he move the Chief's car so they could pass. I walked over to the young trouble makers and ran them off with threats to call the police. They left without any further arguments. When I asked Loyd why he didn't run them off he said, "no way, those guys had a shotgun and they pointed it at me!" My thoughts were, "lonely are the brave." (Or—The Stupid???)

"Adelino" By Luis Padilla (Big Bird)

If anyone ever worked with Adelino Giron you know that stories of his exploits abound. In the early 1980's I was stationed at Fire Station # 7 (47th & Central NW). The crew consisted of Lieutenant Orlando "Hookie" Armijo, Adelino Giron, Tom Skidmore, Simon Hernandez, and myself, (Luis Padilla).

As you know Giron was not the best driver as far as knowing his streets. We had a fire call to a new addition of Artrisco and Coors NW. Adelino didn't know where it was so we directed him as best as we could from the tailboard of the pumper.

After taking care of the emergency and going back in service (10-8) I bet Tom ten to one that Giron wouldn't find his way back to the station. Forty five minutes later we finally found Central Avenue. I made a quick ten bucks off my bet with Tom.

THE TRAPPED FIREFIGHTER By Eugene Baldonado

My most memorable fire was the Coney Island Cafe fire at 500 Central Avenue S.W. It was not that it was such a large fire but the predicament that I got myself into. Chief Art Martinez was the District Chief at that fire. The alarm came in and we had Engine 1A, Ladder 1, Rescue 1, and Chief One responding. When we got there we found that the fire was under the building. Chief Martinez crawled under the building a few feet and could see the fire. He called back to the other officers to send him someone small. Lieutenant Sid Garcia sent me in. The floor joists were 2"X12" with 16" centers and they were about 6" above the ground. They gave me a 1 1/2"line and I crawled in. I had to crawl in with my arms extended above my head because I didn't fit with my arms at my side. I crawled to a low place where I could see the fire and was able to operate the 1 1/2" nozzle. I proceeded to put out the fire. Chief Martinez was at the entrance to the trap door so he yells at me, "when it's all out come on back here." As I was by myself under there I had not noticed that there was a low spot which turned out to be because of a sewer line joint or elbow. All of the water I had put on the fire had begun to flow into the low spot where I was. As I was on my stomach and my arms above my head, there was no room to bring my arms down while holding the nozzle. I had my head between the floor joists just above the water. I tried to crawl forward or backward but my bunker jacket hook had caught on the sewer elbow joint and I couldn't do anything. I tried to get one arm down to get my bunker hook loose but I had no room on my sides.

All the crews were in the Cafe above me and I could hear them talking, laughing, and having doughnuts and coffee but they making so much noise that they could not hear me calling for help or my loud whistling. I managed to get the 1 1/2" nozzle and banged it on the floor joists. Lieutenant Myrick from Rescue 1 heard the pounding and told everyone, be quiet, someone is banging." When everyone was quiet I yelled that I was stuck and couldn't get my bunker coat hook unstuck, or off. I showed them where I was by banging and they cut a hole in the floor above me. Alfonso Padilla reached in and unbooked my bunker jacket. I was sure glad to get out of that predicament.

THE SWAYING TREE By Nicolas Gonzales, Arson Lt. Retired

During 1957 while working at Station #2 at High and Silver S.E. I was working the opposite shift on Engine #2. Adelino Jiron a pipeman had gone to a fire which turned out to be a storage shed in the 1500 block of Edith S.E. During the process of putting the fire out Jiron took the fire hose to a near by tree and climbed up into the tree to get a better vantage point for directing water on the fire. As he was fighting the fire from the tree the tree would sway back and forth as he would turn the pressure on and off.

Within a short time, then Fire Chief Art Westerfeld, who had just arrived at the fire noticed the commotion in the swaying tree. The Fire Chief was enraged to see one of his firemen engaged in such an unusual firefighting maneuver. This was a ridiculous situation and considering the possibility that he could fall out of the tree and cause further embarrassment to the Fire Department really raised the ire of the Chief. As was typical of Adelino Jiron he had the ultimate come back in answering the Chief. "Look Chief, I'm putting the fire out aren't I?"

Gerald Grimm Dies – Regretfully we were notified that retired Fire Chief Gerald Grimm, age 75, passed away on Saturday September 14, 2019. He was hired on February 27, 1978 and was a member of the 17th fire cadet class. The fire academy was located at 1510 Kit Carson SW adjacent to the zoo. When he joined cadets laid miles and miles of fire hose, ran up and down the fire training tower dozens of times a day and were required to jump into the life net in order to qualify as a fire fighter. He went up through the ranks quickly and was promoted to fire inspector in 1972. Two years later he was promoted to Lieutenant and he spent a total of 10 years in the Fire Prevention Bureau. He was promoted to Captain in 1982 and was assigned to the fire suppression division. Three years later Fire Chief Leonard Ortega promoted him to Assistant Chief and he was assigned to head the Paramedic Division. When Ken Shultz was elected to Mayor he appointed Gerald to Fire Chief. After serving as Fire Chief for four years he retired from AFD on December 29, 1989 with over 21 years service. After Gerald's career with the Albuquerque Fire Department, he was appointed to Fire Chief of Texas City, Texas where he had a successful second career. There were 13 cadets in his class and firefighter training was Eight weeks. He was a U.S. Army veteran and after the Army he joined The Trinidad, Colorado Fire Department in 1951. He served nine years In that department prior to joining AFD. During his career with the Department he worked at most stations throughout the City. In 1962 He was instrumental in forming the firefighter's union, local 1455 and Also that year he was successful in negotiating the first firefighter's Union contract with the City. He served several years as the Union President. He was promoted to driver in 1964 and to Lieutenant in 1966. He was promoted to Captain in 1973 and to Assistant Chief in 1974. After David Rusk was elected to Mayor he appointed Leonard to fire chief on March 10, 1980. Overall he spent 34 years in two fire departments, Trinidad, Colorado and Albuquerque. On behalf of the members of the AFD Retired Firefighter's Association our most sincere sympathies and condolences are extended to the entire Ortega family.

Laguna hired AFD retirees and some would call Laguna Fire, Albuquerque Fire West. I am also employed at Presbyterian in the Emergency Room providing Urgent Care which is enjoyable in an environment where the victim/patient comes to you.

The victim insisted they did not need any help, heck that is called denial and we retirees know it! A few times, I told the family they were lucky someone called 911. Even today I've heard that some AFD retirees had put their families through this denial stage. I would tell all our retiree families call 911 immediately and if someone gets upset, gives you the face, silent treatment or makes little remarks under their breath, don't worry, you might have saved a life. Emotions can run high so don't worry about the flack for calling 911, it will be over in a few hours or few years.

The Murphy family have a firefighter tradition started by our father Robert (deceased), brother Michael, my son Daniel EMT-P driver and daughter in-law Judith and myself. My wife Lisa is a teacher with YDI, she has been so supportive, understanding and proud of us all. With 3 grandkids ages 8,4,1 and another on the way, I enjoy being with them when I can. Being a gardener or farmer whatever you call it, I love working and teaching the grandkids about growing vegetables which is a highlight of my time. I attended some retiree meeting which was enjoyable. - 1973 AFD goes on strike, strike last for five (5) days.
- 1973 Three American LaFrance Pumpers put in service with jump seats, semi-closed cab the *first attempt* to retire riding on the tailboard.
- Annual fire hose service test. Every section of cotton jacketed fire hose placed under water pressure, inspected, logged and dried.
- Bi-Annual fire hydrant inspection, every fire hydrant flushed, serviced, and painted.
- 1975 Marx Deer's idea to build wooden lockers that would be used as dividers placed between beds in upstairs bunk room at station. The 6'x8' box was divided into three separate locker compartments one for each platoon.
- 1977 Clark pumper put into service at station one, the first with an automatic transmission.
- 1977 Five-inch synthetic fire hose supply line put on all pumpers.
- January 1, 1978 Albuquerque Title company located across the street from station thirteen (13) located on Indian School Rd NE, burns down. Bishop's Raiders respond.
- 1978 Louie Trujillo implements the Physical Agility Test as part of the hiring process.
- 1980 Heavy Steel apparatus doors @ station 1 that would retract directly straight up into the wall, replaced.
- 1983 City Hall catches fire on the fifth floor, ladder one front page (we) put it out.
- 1984 AFD receives its first WANG computers which were used as word processing no internet service available.
- 1984 Herman Bishop orchestrates organizing all written material used or referenced by AFD. The large amount of material was cataloged and placed in 10 volumes. No photostats allowed all material was retyped in one format, stringent guidelines for maintenance was adhere to.
- 1986 Hypalon (grey rubber) bunkers tested and found unsafe and not meeting any safety standard. All are required to be replaced as Nomex being the new standard.
- 1990 Fire Academy relocates from 1510 Kit Carson S.W. to 11,500 Sunset Gardens SW.



task force which will be forwarded to the N.M. State Legislature for consideration in January, 2020. Generally the recommendations include a plan to reduce PERA's unfunded liability within 25 years, propose freezing COLA's for three years but give an annual lump sum payment of 2% at the end of the next 3 years. Recommend low income retirees (below \$25,000 per year) be exempted from suspension of the 2% COLA. The proposal will eliminate the 7 year wait to receive annual COLA's and reinstate the two year calendar wait.

The President's report was given by Kerry Horton. He thanked retirees who assisted active duty firefighters in the successful "Haunted Halloween Tower," event hosted at the fire academy Halloween night. Kerry invited retirees to join him On December 4, 2019 to attend the Investment and Pension committee meeting in Santa Fe. We will meet at the Union Hall that morning and car pool to Santa Fe. The Secretary's report was given by Fred Casias. A motion to accept was made by Ed Abieta, and was seconded by Bill Raupfer. The Motion passed. The Treasurer's report was given by Mike Fox. A motion to accept was made by Phil Candelaria and was seconded by Donnie Sanchez. The motion Passed. The Historian's report was given by Herman Bishop. He read a letter from Victoria Ortega thanking members of the retiree's association for the beautiful memorial service recently conducted in memory of her father, Fire Chief Leonard Ortega. Sam Trujillo presented a thank you letter from the family of "G.O." Garcia thanking the retirees for the beautiful memorial tribute given at funeral services for "G.O." Condolences are extended to Raymond Sedillo on the recent loss of his wife Francis. The closing prayer

was led by Morris Gutierrez. The meeting Adjourned @ 8: 43 PM.

In 1969 during the cold war, the National Civil Defense Organization made matching funds available to cities throughout the United States to develop and form auxiliary volunteer fire brigades to assist organized fire departments during war, nuclear attack, natural and man made disasters. In Albuquerque fire Captain Herman R. Bishop was appointed to plan, develop, and implement a cadre of citizen volunteers to augment the Albuquerque Fire Department during Major fires, nuclear attack and disasters. He was assigned to the local Office of Emergency Preparedness with the title, Fire and RADEF Officer. The director of the organization, Mr. George Dunham was part of the City Manager's Staff and Bishop was



the Fire Department liaison assigned to that department. Locally Bishop developed a firefighter training program (40 hours) recruited and trained 40 volunteer firefighters at the fire academy. They assumed the title, <u>"ALBUQUERQUE FIRE RESERVE ASSOCIATION."</u>
Because Bishop headed the program, and trained the volunteer firefighters, the active duty firefighters affectionately named them "Bishop's Raiders,"

Once the volunteers completed training they were certified as firefighters and were assigned to work shifts, nights and weekends by riding with the on duty District Chiefs throughout the City. The volunteers were on call and were called in to major fires, second alarms and greater. Some famous fires they assisted in were: Many river bosque fires, The Winrock Apartment Fires, Brunicinni Appliance Store Fire, Montgomery Apartment Fires, Rio Grande Title Fire and many other second alarm fires. The auxiliary fire brigade served with AFD for about 10 years (1969 to 1979). The last few years the volunteers served, they Provided fire protection at "Speedway Park." a local stock car race track, located On Eubank Boulevard SE, adjacent to Kirtland Air Force Base.

This logo/decal was developed and used by the "Albuquerque Fire Reserve,"

Volunteer firefighters during their tenure with the Albuquerque Fire Department. After the volunteers disbanded, Retired AFD District Chief Paul Graves Kept this decal as a souvenir for 25 years. In 2019 he brought it back to be displayed in the AFD Fire Museum


