

Chief Celaya is a former Deputy Chief of the El Paso, Texas Fire Department and spent 27 years on that department. He joined the Department in 1987 and served first with the ambulance paramedics, then transferred over To the firefighting division as a firefighter. He served in all ranks from firefighter through Deputy Chief. He served in all major divisions, pumpers, ladders, rescues, Training, Fire Prevention, EMS Chief, Operations Chief and Fire Administration. He is excited about his new job and believes he has joined a top notch department. Currently the department has A 22 million budget, 250 personnel, 10 Engines, 2 Ladders, and 12 Rescue Units. Their Pumpers are staffed with 3 firefighters, Ladders 3 firefighters and Rescues 2 FF/Paramedics. Chief Celaya was given a big welcome by AFD retirees at their June, 2015 meeting.





Juan A. Vigil Dies - Our brother retired firefighter Juan A. Vigil, age 88, passed away on Saturday his older brother Manuel Vigil who also was a career Albuquerque firefighter. Juan joined AFD on Llano de San Juan, New Mexico, near Penasco. He was a United States Army veteran. He followed Dallas, Texas to attend the graduation of his grandson when he suddenly fell ill. Juan was born in SW, established a Fire Prevention Bureau, a Training Division, and started the first rescue squad firefighter. During 1957 the department built the new Station # 1 at 8th Street and Silver Avenue May 23, 2015 while traveling on vacation in Amarillo, Texas. He and his family were en route to February 15, 1957 and retired on October 30, 1983 after serving 26 years as an Albuquerque housed at Station # 1.



The Ray Sedillo Story

I remember hitting the bottom of the pool and the weight of my bunkers

I retired 27 years ago where I worked mainly in district one (1) and assigned to Engine 6, Engine 7, and Engine 10 Ray said. My final career assignment was at Engine 10 it was great because I lived in the area I would walk to and from work, so you could say it was the greatest years in ending my career. I was given the nickname "SADIE"

Sadie said all the stations that I worked at, I would offer to cook. At Engine 6 the officer was the cook Manuel (Pinto) Vigil. He would be the one that would ask me to cook and would say Sadie you cook today I need a break. At station 10 I would ask the troops what would



you like for lunch today? Someone would say pork chops, another would say hamburger steaks etc. one particular firefighter would always say **NO**, no matter what was suggested, he said I had that at home last night or going to have that tonight. That went on with him for a while so it turned into not asking and telling him "just eats what's cooked or you can starve"..... That fixed the problem. My specialty was homemade bread and I enjoyed making it. Maybe that's why...when I floated to a certain station the meal being cooked was perfect for fresh baked bread.

Everyone has a call that they remember for whatever reason Sadie said, while floating into Engine 4 we had a fire call at night in a residential area. There was heavy smoke a lot of it and looked like the whole neighbor hood was on fire. I caught the hydrant with the 5 inch hose and when signaled I opened the hydrant and followed the hose back to the truck. I headed toward the house to join the crew who were in the rear of the house, visibility was zero. Walking toward them in full bunkers unannounced I stepped into the middle of a swimming pool I went down like a rock. I remember hitting the bottom of the pool and the weight of my bunkers, I pushed with my feet as hard as I could to surface....don't know how I did it but made it to the end of the pool. The firefighters rushed to my side and pulled me out of the pool they made sure I was OK.....seconds later I said I am OK ... without missing a beat Pablo Garcia Jr. said immediately are you sure your OK Mark Spitz? Sadie said these guys are something else!

Sadie talked about other experiences and said; I was awarded a citation for a rescue, working with Jonnie Mares we were at a house fire where it was reported someone was inside. We went in immediately to search for the victim without putting on our self contained breathing apparatus, it was hot, eyes burning and we were choking from the smoke. I stumbled over something which turned out to be the victim, I grabbed what I could which was his feet and started pulling him out of the house. The thing about it was there were stairs and his head bounced down each step of the stairs as I was pulling him out, oh well, bottom line he survived.

The call that bothered me a lot, I was just out of training and we had a rescue call a 10-45 (MVA) on Broadway a child was in the mangled car and in serious condition after our rescue was completed and the occupants transported to the hospital, then it hit me I started to think "I have small children" it could have been my kid in that car. I could not wait to get home and hug my kids it makes you thankful that your kids are safe!

Upon my retirement I bought an old house, remodeled it and became a landlord over night It continued with other properties where I sold a few. However just like a lot of ventures after a while it's not fun anymore just work so now it's become a thing of the past.

With all the kids grown and gone we have 5 grandkids and 1 great grandchild. I dedicate most of my time taking care of my wife Frances who has some medical problems Sadie said. Looking back what a wonderful career and life..... I look forward to our retiree meetings each month great place to be visiting with all the old friends

The Ralph Padilla Story by Eddie Abeita This type of call never goes away or at least not in the past 25 years!

I retired from Albuquerque Fire Department December 28, 1992, that was 23 years ago or just think a firefighter starting his/her career with the fire department when I retired, could have completed their career and now be retired said Ralph.

My first assignment after graduation from the fire academy was at ladder one, in those we used double jacketed fire hose, with it being cotton or nylon you washed tested and hung a lot of fire hose. Day or night over the intercom someone would announce "everyone to the hose tower" to wash and hang hose, it most likely had just been used at a fire. On the day shift it was take down the dry hose, roll



and stack it. The ladder crew would fill self contained breathing apparatus (SCBA) for a lot of companies the fill station was a cascade system no compressor just large bottles of air.

I was transferred to other engine companies but my last assignment was at Engine 7 where I was there for 13 years and that's where I retired from. Working with other crews was always an experience, you always learn something new even if was a minor thing. One thing when an alarm came in it turned into our business and everyone performed as duty called Ralph said..

During my career I experienced good and bad incidents some we think about and others we try to forget but I think that's happens to all firefighters during their career.......

One call I think about from time to time happened on New Year's Eve while assigned to Engine 7, the alarm/hit and dispatcher said; a 10-45 (motor vehicle accident) on St Joseph Drive with trapped occupants. The officer Lieutenant Robert Murphy said while putting on his bunker coat that's Engine 17's run they must be out. Driver Phil Lovato handled the Mack pumper real well, when he turned onto Coors Blvd. he had the Mack wide open, I think what was going through all our minds was "trapped occupants". There were 3 passengers in the car that flipped upside down police and bystanders were able to pull two of the occupants out from the front of the car. Just as we arrived the car blew up being upside down and gas leaking it immediately became fully engulfed in fire. The 3rd occupant was trapped in the back seat of the burning car. Lieutenant Murphy called for the 1 1/2" hand line for needed volume of water. We did what we could as the final screams were heard coming from the car, the feeling of helplessness was so heavy. This type of call never goes away or at least not in the past 25 years!

We did a lot of cooking at Engine 7; green chile stew was always a favorite with sopapillas or tortillas. When it was my turn to float to another station the captain at station 4 would say you are floating here to cook for us. One thing I liked to do was play ping pong at fire station one and four there were a lot of players so you could enjoy hours of playing ping pong. When I first started I chased the ball a lot but picked the game up and then it was my turn I had others chase the ball. You would be surprised on how good firefighters were at playing ping pong.

After retirement I volunteered to help with some *minimal* handyman type repairs at Holy Family Church It's hard to say NO to the church. Retired CEO Gene Romo who was involved with Holy Family Church

asked me about my other talents, I said heating ventilation air-condition (HVAC) repair. Boy oh boy it turned into a job, which later Gene Romo placed me on payroll which seemed OK at the time because the amount of work was getting bigger and bigger. Six (6) years later I hurt my knee so that slowed down my productivity so I later resigned and once again retired (yeah).

I never had an actual nickname given but heard a lot of what you would call "short jokes" maybe because I am 5 foot 2 and eyes are blue. With our 3 grandkids one being 21 years old they keep my wife Dora and I busy. My career as a fire fighter with AFD was one of the most gratifying and rewarding experiences in my life and what a wonderful retirement package. Just like Heaven "God Blessed Us"!

The Phil Lovato Story

I guess you could give our platoon credit for making two parking lots on the same block!

Phil retired from AFD in December 1992 after 20 years of service. His last duty assignment was at Engine 7. Phil was ready for retirement in October 1992 however fellow firefighter Ralph Padilla was going to retire in December of that year so Phil said I will retire with Ralph and makes it a twosome exit..

Phil said after graduation from the fire academy his first assignment was at Engine 2. In those days we rode on the tailboard of the truck, Engine 2 had a large running and backup district. I remember some large fires that we responded to in the downtown area one was Mike London's Wrestling Center on Copper NW the fire occurred in the late evening.



Upon our arrival the owner Mike London had escaped the fire and ran out of the building only wearing bikini underwear, the District Chief yelled someone cover him up! An offensive attack was made on the fire with 2 hand lines (2 1/2"), a skylight created a natural opening and was venting the hot smoke and gas up and out of the building, that was short lived all of a sudden the ladder truck opened its master stream and shot down water directly into the ventilation hole. The crews inside the building were forced out by the tremendous amount of heat and smoke being pushed on them, I can't tell you what was said because of the language used by the steamed firefighters!

Another fire happened on the same block except on the Central Avenue it was a stubborn fire. Most fire units were on scene from about 8:00PM until shift change the following morning at 8:00AM, temperature dipped to 20 degrees that night and just thinking the fire that was keeping us a little warm we were trying to put out. I guess you could give our platoon credit for making 2 parking lots on the same block.

As I said we had a large backup district even backed Engine 14, we had runs to the Gun Club Edition in the far south valley. The location was in the county however the Gun Club Edition was annexed as city residential property. Bernalillo County Fire did respond under a mutual aid agreement but AFD always would respond accordingly. Calls at night to Gun Club, were interesting because while in route you could see across the valley the flashing Mars light from Engine 14 also in route, it kind of turned into who would get there first.

Back then there was no social media so most fires did not get any publicity which could be a good thing. We were dispatched to a house fire and it looked like a good working fire so the officer had us catch the

first hydrant he saw however that was not the closest hydrant to the house. About 25 feet from the house we ran out of hose, all 1600 feet of 2 ½". Upon our size up and investigation, we paused at the back kitchen door and look at each other because we all recognized the smell of burnt food, yes sir it was burning beans on the stove...

When promoted to driver Phil floated in district one to fill in where needed. Phil said when driving at Engine 14 emergency calls could be long and tiring. It was not uncommon to have calls out west on I-40 toward Laguna. Semi-truck drivers would send out calls for help on their CB radios people monitoring the truckers CB radio would relay the message by phone to AFD dispatch. These calls were tuff calls because you never received enough information so sometimes the exact nature of the call was not known until arrival.

Phil' first permanent assignment as driver was at Engine 7, he remembers with any truck, it was Important to insure your truck and equipment was ready for emergency response, this was done at start of every shift and after every call. Engine 7 was an open cab 1,000 GPM, 5 speed, Mack diesel pumper, the radiator had louvers thermostat controlled that would open and close depending on engine temperature and of course the chrome bulldog mounted on the top, this particular truck was a great running piece of equipment and looked good.

Phil said.... and there are some calls that you don't talk a lot about, or hope nobody finds out about. We had a brush fire on the river bed and the road we took looked good but ¼ mile in the axle was buried in sand. The logical thing is to radio for a wrecker in which the whole city will know you buried your truck. We got lucky another governmental entity was in the area with a big front end loader. The operator yelled out hey "Need some help"? Heck yes I yelled back,...Prayer answered... Phil said smiling.

Phil said he would cook now and then to change the food taste, one dish was Chinese he called Hog Suey, a pepper steak configuration with rice it was real tasty based on the fact there were no leftovers. One tradition in AFD I could not understand was, on your own birthday why **you** bring the cake and ice cream?

Phil enjoyed sports but his game was fast pitch softball and played in the city league with fellow firefighter Bobbie Baca who both would pitch and play other positions. Phil was asked to traveled to El Paso TX to play in the annual softball game between the 2 fire departments. Phil was called upon to pitch in the first game, Phil took center stage with his junk on the ball he controlled the 1st and championship game, El Paso Fire named Phil the Most Valuable Player of the series.

Phil said what I want to know is now being retired why do we get targeted and bombarded with junk mail and advertisements? I get all these advertisements and stuff in the mail and elsewhere. Ads for hearing aids, pain medications, diabetic testing, fiber help, pills to make you smile, hide the wrinkles, cream for cracks on your body and all other kinds of stuff?

Today Phil and his wife Lottie enjoy their 3 adult children and came out of retirement to help with their 6 precious grandchildren. Its quality time anytime you can spend time with the grandkids even just to chuffer them around the city Phil said.







Rather than aggravate him further, I stopped in front of Station 1 and spoke to a couple of Firefighters that were outside. I advised them that my dad was Retired AFD with Alzheimer's and that he was having a bad day. After first inquiring whether or not my Dad needed to be evaluated for any other health issues, they told me to bring my Dad inside the Fire Station.

The Firefighters of A Shift were so accommodating and welcoming to my Dad that I just DO NOT know how to thank them and express my appreciation. They sat down and spoke with my Dad about the time he spent with AFD, they gave him a tour of the Station, and they just showed him the utmost respect and thankfulness for his past service that I was speechless.

I would like to thank the members of the Albuquerque Fire Department and particularly A shift at Station 1 for treating my Dad the way they did. They even sent me a text inquiring as to his health and well-being about a week later. A shift- you really helped me out. I appreciate each and every one of you and thank you for the way you treated my Dad and made a rough night much more bearable.


